A RESOLUTION APPROVING THE ADOPTION AND SUPPORT OF THE COMMUNITY COVENANT TO HONOR AND CELEBRATE THE MILITARY MEN AND WOMEN OF TOWN OF DANIEL AND THEIR FAMILIES, AND ALL MILITARY MEN AND WOMEN AND THEIR FAMILIES WHO HAVE SERVED, OR ARE PRESENTLY SERVING IN THE MILITARY, AND THEREBY ARE COURAGEOUSLY SUPPORTING AND DEFENDING OUR COUNTRY

Resolution:

WHEREAS, Town of Daniel recognizes the commitment and sacrifices that military men and women, and their families, have made and are continuing to make for our country each and every day; and

WHEREAS, Town of Daniel recognizes the past sacrifices and heroic efforts that military men and women, and their families have made for our country; and

WHEREAS, the men and women of the United States Armed Forces are constantly preparing to once again deploy to defend our country and the values upon which it has been built, and to advance the principles of freedom at home and abroad, and

WHEREAS, Town of Daniel acknowledges that “freedom is never free” and military men and women of the state of Utah, and their families, as well as ALL military men and women, and their families, who have served or are serving their country, are paying the price for freedom for all citizens of our country.

NOW THEREFORE, at a regular meeting of the Daniel Town Council, held on May 6, 2013, upon motion duly made and seconded, it is resolved as follows:

- 2) Town of Daniel is appreciative and is in debt to the men and women who have supported our country through their courageous and meritorious service.
- 3) Town of Daniel approves and is committed to assist in the implementation of the Community Covenant.
