• 1) Public Comment: issues limited to 2 minutes, per person - to be read.

• 2) Bassett: Residential Building Permit.

• 3) Munford: Residential Building Permit.

This is on John Glodowski subdivision lot 2. The planning report was handed out. The report from TO not yet available. The planning report was discussed. Flashing needs more detail. The separation of the barn and house needs to be specified.

Commissioner Skinner moved to approve the Munford residential permit with the conditions that are listed above and that the findings of deficiencies are all corrected and after the review has been conducted by the TO engineering staff and a weed control, culinary, fire, irrigation plan is in place. Commissioner McCallister seconded the motion. There was no discussion on the motion. Commissioner Bunker called for a vote. McCallister aye, Weight aye, Bennett aye, Skinner aye. Motion passed.

Commissioners Bunker, McAllister, Norris, Rawlings terms are complete as of the first of the year and will need to submit a letter of interest if they wish to remain on the commission.
